CPHI & PMEC China 2024: Another Feather in the Cap

Asia's largest pharma event wrapped with a great success in connection and innovation

On 21 June 2024, CPHI & PMEC China 2024 came to a successful conclusion at the Shanghai New International Expo Center. This 3-day exhibition brought together the collective efforts of the global pharmaceutical industry, continuously exploring integration and innovation, and making positive contributions to optimizing the pharmaceutical ecosystem and pioneering new heights of development in the pharmaceutical industry.

As a globally renowned brand event in the pharmaceutical industry, CPHI & PMEC China has consistently upheld its original mission and pursued continuous innovation and improvement during this critical period of medicine & health industry reform and advancement. CPHI & PMEC China 2024 occupied a total exhibition area of over 220,000 square meters, covering 26 halls at the Shanghai New International Expo Center, reaching a new record scale. The three-day show welcomed 3,358 exhibiting companies and 63,467 professional visitors from 135 countries and regions, of which nearly 25% were international visitors, setting a new record for the highest attendees of visitors and exhibitors in the history of the event.





Top 10 domestic visitors' area breakdown








