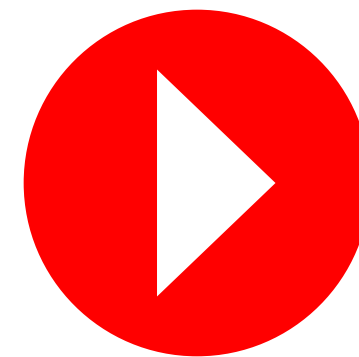

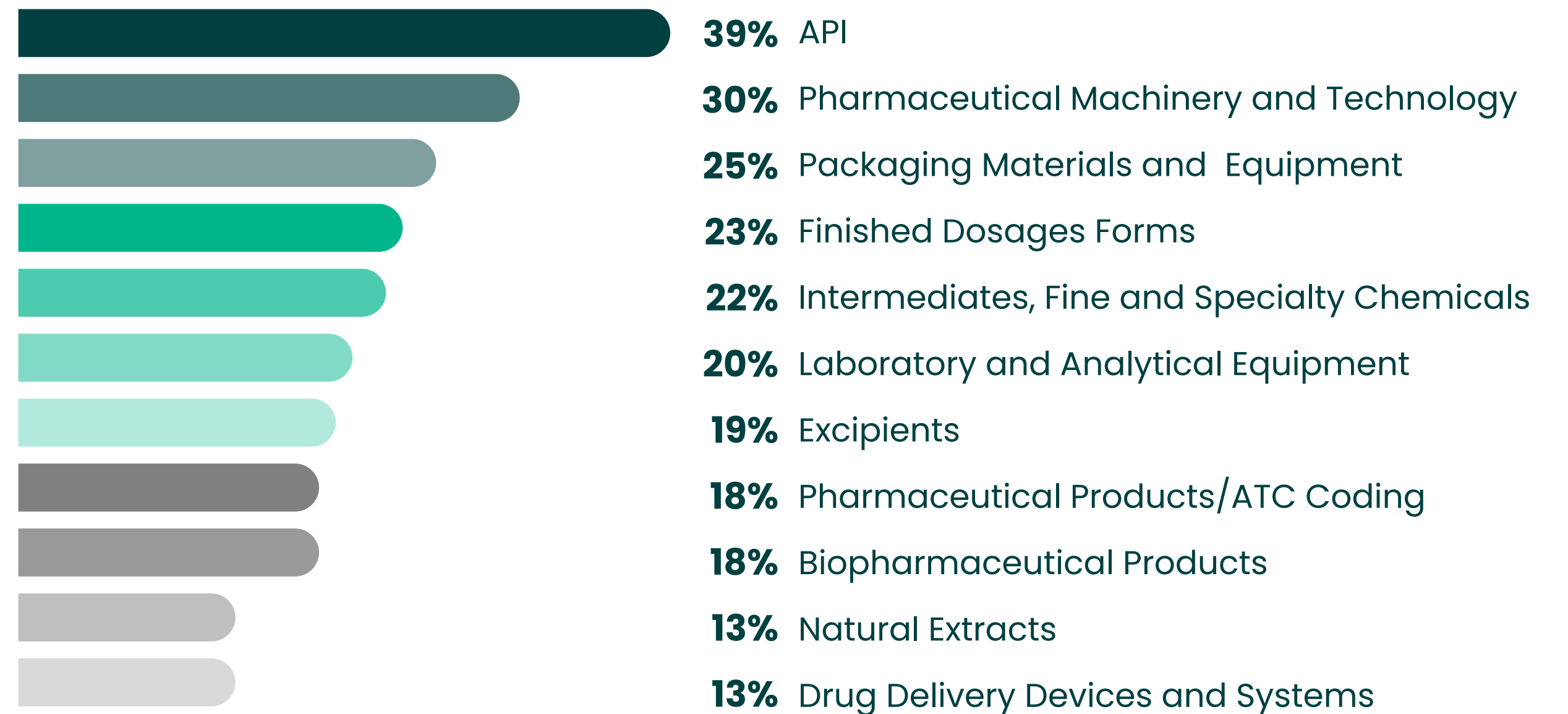

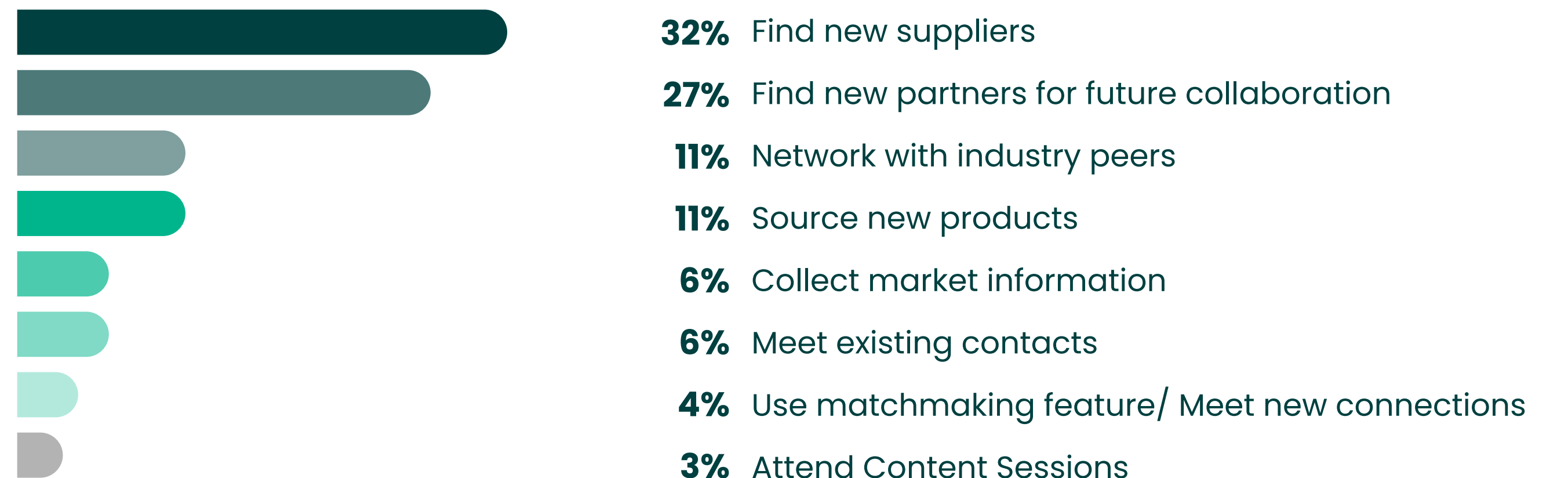

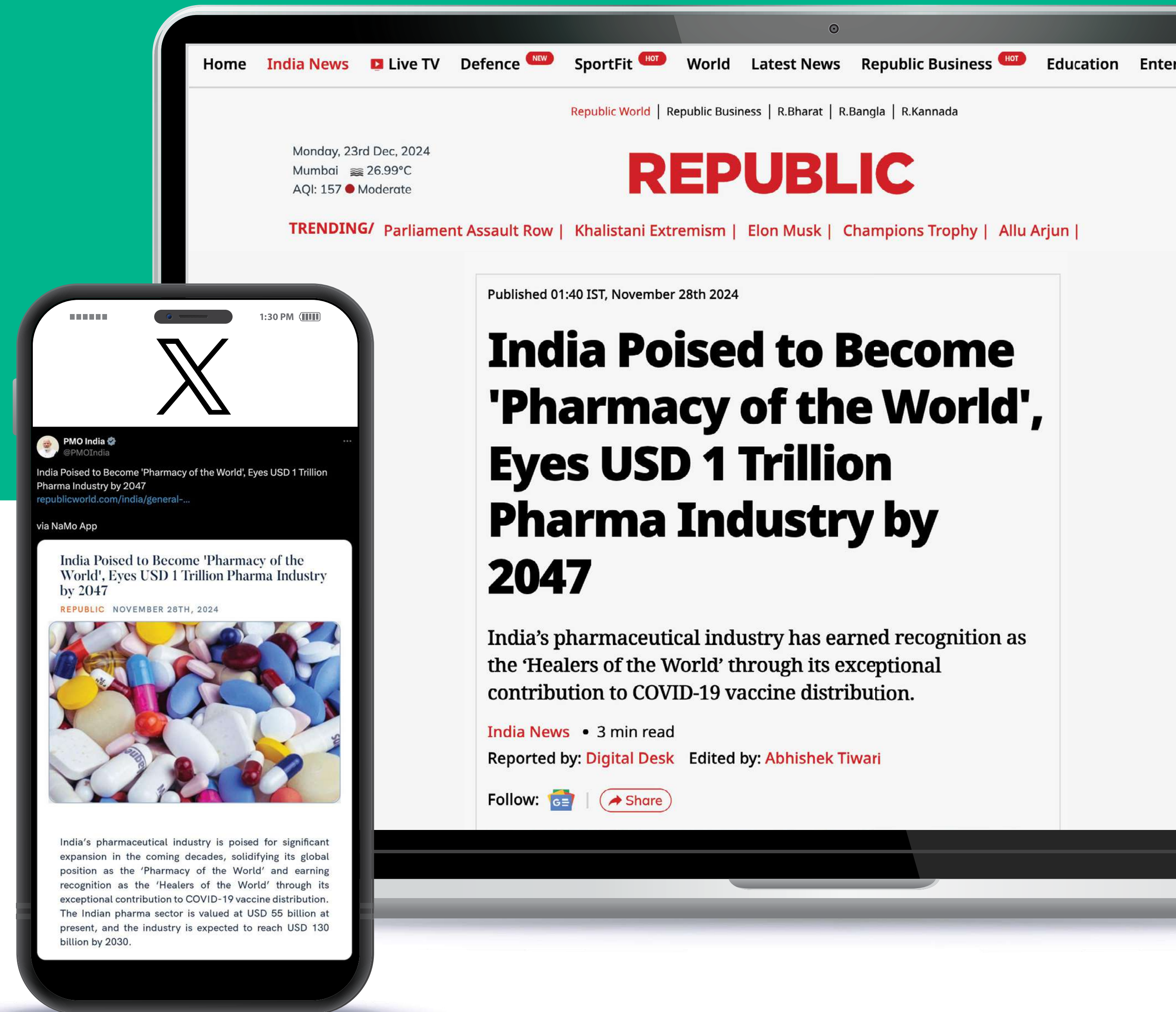
Media Highlights

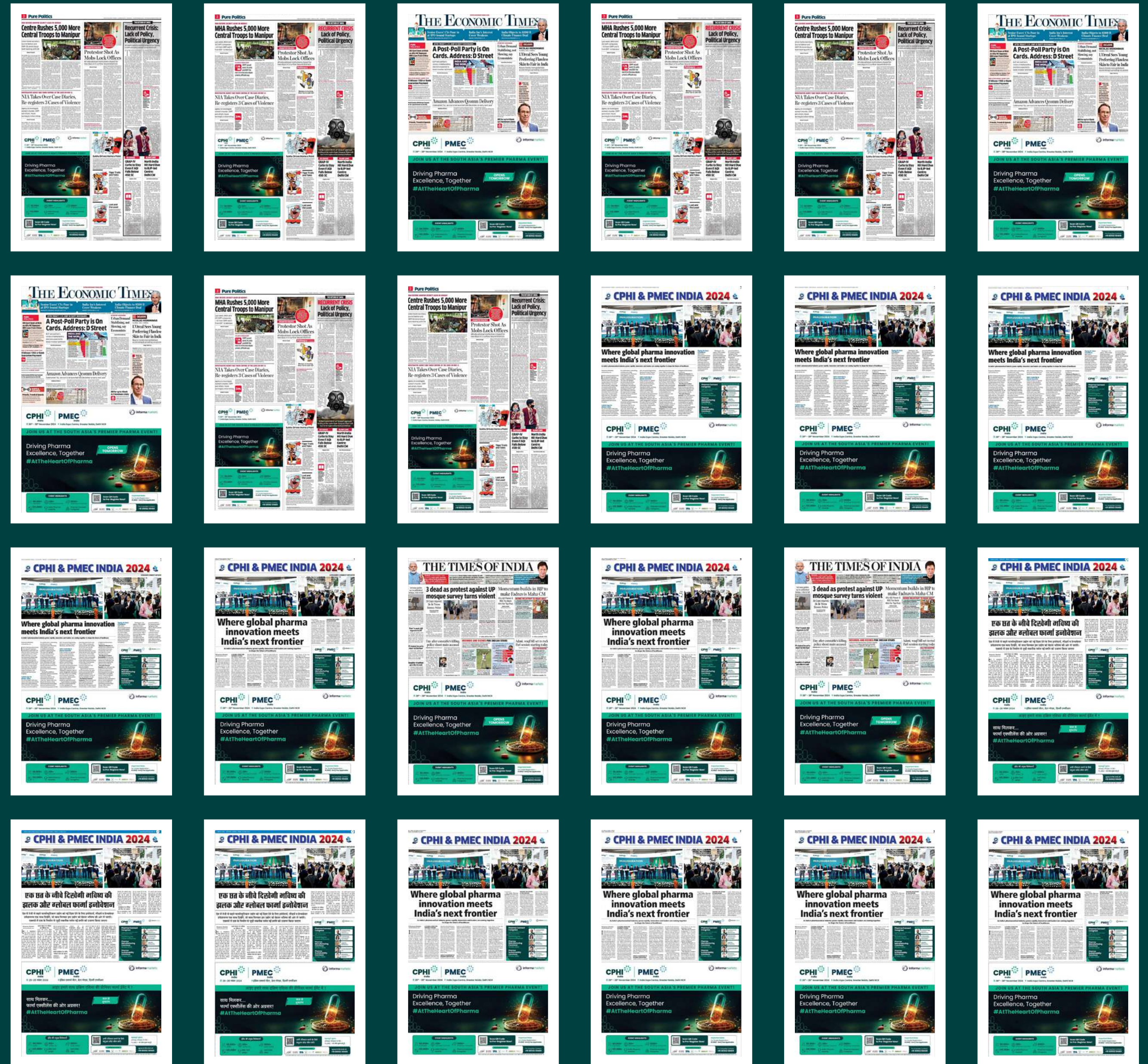
